## **Dream Academy Financial Policy**

Dream Academy is a nonprofit corporation. Our financial policy is to make sure every family can afford an education with us. In order to sustain operations, we need to ensure timely funding. We accept all Florida Scholarships and Cash Payments.

- Tuition \$7500
- Registration \$250
- Technology Fee \$250

### **Cash Payment**

Cash-pay families will be invoiced for tuition in equal quarterly amounts on or around September 1, November 1, February 1, and April 1. Registration and Technology fees will be included in the first invoice. Payment is due upon receipt. For enrollment within the school year, there will be no prorating of tuition, however, it will be charged from the quarter of entry. The amount will be billed immediately for the current quarter. No refunds will be issued, and in case of withdrawal, see the withdrawal policy below. Additional payment options may be available which would need to be handled and approved at the time of enrollment.

### **Scholarship Students**

#### **Admission Prior to Scholarship Application and/or Approval**

Dream Academy believes in providing opportunities to ALL students regardless of their situation. We will accept enrollment, pending funding for those that would otherwise qualify for the various options above. Students can start immediately, with the agreement that families agree to adhere to the following:

- Complete and Submit ALL Application Information in a TIMELY Manner
- Provide Dream Academy with the Application # within 15 days of Enrollment
- Check Status WEEKLY and provide Dream Academy updates
- Complete any other applications and documentation as requested by Dream Academy pertaining to potential scholarship funding

## **Dream Academy Financial Policy, cont.**

**Failure to complete an application and/or documentation by established deadlines will result in the suspension of student access and invoicing for Tuition Due. If the scholarship is denied for Income or Available Funding Reasons, please contact Dream Academy ASAP. If alternative payment arrangements are not made within 15 days, the student will be withdrawn and the laptop and any other materials must be returned. Payment will be required for the Quarter(s) enrolled. Invoices are due 15 days from issuance.**

### **Approval of Scholarship Payments**

The Florida Department of Education and the Scholarship Granting Organizations will email Payment Approval requests. **Payments should be approved within 5 Days of notification.** **FAILURE TO APPROVE** will result in invoicing for full tuition and Failure to Approve will be reported to the Department of Education and the Scholarship Granting Organization, which may result in the Scholarship being revoked and future opportunities being impacted. If at any time you need assistance please don't hesitate to contact your scholarship organization and or Dream Academy.

### **Internal Scholarship**

For some scholarships, a student might not obtain the full amount of Dream Academy tuition, registration fees, and technology fees. We at Dream Academy understand that there may be a shortage in funds that are awarded to the child vs the total amount due to the school. In the event that a parent is not financially able to pay these differences, Dream Academy will put these differences in the Dream Academy internal scholarship program for up to 50% of tuition and fees. To be considered for this program, parents will need to provide the last 30 days of paystubs for all within the household, and the total household member count. This is the information that was sent/uploaded to your scholarship application as well.
